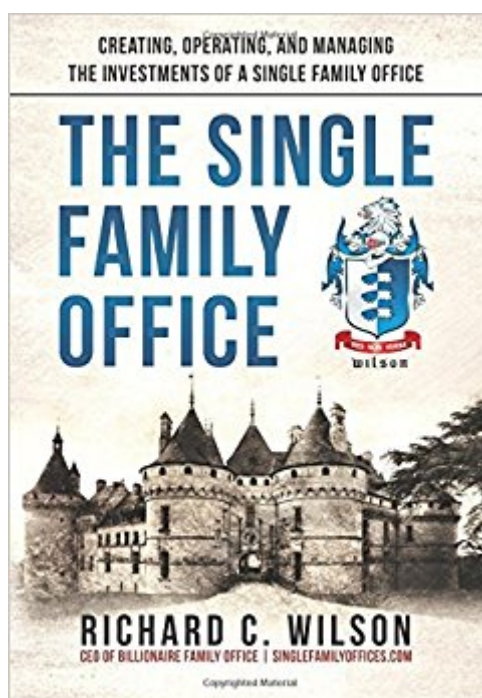

There is a ton of information in every chapter from other sources as well. Mr. Wilson interviews top Family Office Managers and Principles and gleans the very best information that is educational to those wanting to start a family office at any level or experience. I recently was able to take the knowledge from this book and apply it at a recent CIO and REI Allocation Summit and left with 32 new contacts and friends which includes 4 ~ 6 big (over \$100 Million) family offices. I highly recommend this book for anyone interested in learning more about family offices and working with them.

Just finished reading this Single Family Offices book by Richard Wilson. He has some excellent perspectives from the single family office CEO & CIO perspectives in this book and could even take the place of hiring an expensive family office consultant. My one critical comment is that while roughly 30% of the book is focused on starting a family office, I do wish it had even more details on this area...but it still is the best resource I have found so far on this topic. Highly recommended.
